Update on Puerto Rico Dams Early Warning System Project


Since the August 2025 update, substantial progress has been made on the project that consists of seven groups of dams. The first two groups have been completed in line with the project plan and scheduled milestones. The Puerto Rico Electric Power Authority has requested further capabilities for these groups for which Genasys will receive additional compensation.

The third group is the largest and most complex of the project with ten dams and the installation of 50 outdoor speaker arrays and over 100 sensors and cameras. This group is being executed with field activities currently underway. All the hardware and equipment necessary to complete the third group is on the island.



Regarding the fourth group, Richard Danforth, CEO of Genasys, stated, "With our recent receipt of the multimillion-dollar deposit, site surveys and engineering design activities have started and will continue over the next few months. We are on track to execute the next phases, including the three final groups, and expect the project to be completed in 2027 with the majority of the work taking place this year."



LA City & County Officials Use Genasys Protect to Issue Evacuation Warnings and Orders During Recent Atmospheric River Events

Los Angeles city and county officials issued a series of evacuation warnings and orders in advance of the atmospheric river storms that dumped several inches of rain on the Los Angeles area, flooding some roadways, triggering rockslides in some mountain areas and triggering debris flows in recent burn areas.

The city of Los Angeles issued evacuation warnings for residents of Pacific Palisades and Mandeville Canyon near the Palisades Fire, and south of Runyon Canyon near the Sunset Fire area.

Los Angeles County officials issued evacuation warnings for residents near the Palisades, Eaton, Agua Dulce, Lidia, Franklin, Bridge, Canyon, Owen, Hurst and Kenneth fires.

Sheriff Robert Luna said 124 homes in the sheriff's unincorporated coverage area were under evacuation orders. County Public Works Director Mark Pestrella said roughly 260 other homes in various incorporated cities — including the city of Los Angeles — were also under evacuation orders.\

Luna urged residents to heed the evacuation orders and warnings, saying those who failed to do were “putting your lives at risk.”

Residents were urged to check the evacuation status of their neighborhoods at protect.genasys.com.

Evacuation Warning Issued for Pasadena – Altadena, CA Foothills Ahead of New Year's Eve Storm

“Los Angeles County officials issued an Evacuation Warning to residents living in and below the Eaton Fire burn scar in the Pasadena and Altadena foothills, urging households to prepare for possible evacuation as a new storm approaches already saturated ground.

The Los Angeles County Sheriff’s Department announced that the directive applies to neighborhoods in the San Gabriel Foothills near Altadena, an area severely damaged during the Eaton Fire earlier this year.

“Evacuation Warning for EATON FIRE burn scar area starting Wednesday December 31, 11am due to possible mud or debris flows,” the Sheriff’s Department said in an **Alert LA County** message. “GET SET for possible evacuations.”

Residents were urged to prepare and monitor Alert LA County and **Genasys Protect** for any escalation from a warning to a mandatory evacuation order.”
